WAIVER OF ALL POSSIBLE CLAIMS AND ASSUMPTION OF RISK

I desire to participate in the above activities sponsored or organized by Free Life Church (FLC). I understand that in order for FLC to accept my application, and my being permitted to participate in the above activities, I must agree to be bound by this Release, Waiver and Assumption of Risk.

I waive any and all claims I may now and in the future have against, and release from all liability and agree not to sue FLC, FLC Youth Leaders and attending participants and chaperones (collectively "the Released Parties") for any personal injury, death and property damages, expenses or loss sustained by me as a result of my participation in the above activities due to any cause whatsoever.

The undersigned further agrees to abide by all rules and codes of conduct during the above activities.

I hereby agree and acknowledge that any claim or dispute arising from or related to this Release, Waiver and Assumption of Risk, any of the rights or obligations granted herein, or the relationship of the parties in any respect thereto shall be brought within 12 months of any occurrence or discovery (or forever waived), shall be governed by the laws of the Commonwealth of Virginia, and shall be settled only by mediation, or, if necessary to resolve the dispute, by legally binding arbitration in accordance with the then current rules of procedure for Christian conciliation of the Institute for Christian Conciliation of Peacemaker Ministries. All such mediation and arbitration shall take place in Leesburg, Virginia. Judgment upon a mediation or arbitration award may be entered in any court otherwise having jurisdiction, and such mediation or arbitration is the sole remedy and is non-appealable.

I confirm that I am the full age of majority or, in the alternative, I have indicated that I am the guardian of the minor participant named, and that I have read and understand this agreement prior to signing it and agree that this agreement will be binding upon me (as participants or guardians).

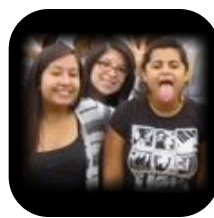
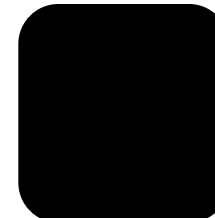
